



STUDENT WAIVER AND RELEASE FORM

This waiver and release form is a contract with legal consequences. Read it carefully before signing. In consideration of my request to participate in the Point Blank Enterprise (PBE) shield workshop, either as a participant in the training course or as a spectator, as a requirement of participation, I make the following contractual representations and agreements:

I understand that the activities involved in the PBE shield workshop are extremely physically demanding, and dangerous and that they have been fully explained to me. I further acknowledge the dangers and potential risks they represent and affirm to the administrators and staff of the PBE that I have trained and am physically fit to perform such vigorous and strenuous activities without any threat to my health or safety.

I also represent that I am aware that live ammunition and potentially dangerous equipment will be used during the training by myself and others, and this presents an additional danger/risk through accidents, misfires or other unknown or unforeseen events that may result in injury or even death.

I recognize and accept all and every potential danger, known and unknown associated with participating in the training and fully assume the total responsibility for all possible risks, where obvious or latent, associated with my participation even though it may result in my injury or death. I also agree to participate safely and in accordance with directions of instructors, the rules and judgements of the authorized Point Blank instructors, their decisions in all matters are final.

As a result of my full understanding of the requirements, the dangers and my acceptance of risks, I hereby waive, release and discharge for myself, my heirs, legal representatives and successors in interest (hereinafter, collectively "successors") any and all rights and claims for all and any matters arising from my participation in any PBE activity (training, competition, social gatherings), with no exceptions, which I have or which may hereafter accrue to me against the administrators, owners, sponsors or staff of PBE. Specifically, I waive my rights to sue or make claim for any reason what-so-ever, and to hold totally harmless PBE, the host organization, the sponsors, and all other associated persons or entities, without limitation, of any fault for any claims, for any physical injury, death, or for any damage to property arising out of or in any way related to PBE or my attendance at or participation in any PBE activity.

I agree for myself and my successors that the above representations are contractually binding and are not mere recitals, and that should I or my successors assert any claim in contravention of this agreement, I or my successors shall be liable for and agree to pay all expenses (including legal fees) incurred by the other part/parties. This agreement may not be construed as modification of any or the provisions herein or consent to any subsequent waiver or modification unless placed in writing and agreed to by PBE administrators.

I realize PBE can be a media event. I agree to allow the administrators and sponsors of PBE to use my likeness in photo/video for commercial, promotional purposes and/or media releases at no charge or compensation.
